## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of THRUSH CREEK AND RESERVOIR, CONSTRUCTED UNDER PERMIT R-2465, a tributary of COQUILLE RIVER, for the purpose of IRRIGATION OF 9.0 ACRES AND FLOOD HARVESTING AND TEMPERATURE CONTROL ON 18.9 ACRES.

This right has been perfected under Permit 42293. The date of priority is APRIL 15, 1977. This right is limited to 2.84 CUBIC FEET PER SECOND; BEING 0.23 CFS FOR IRRIGATION, 0.60 CFS FOR FLOOD HARVESTING AND 2.84 CFS FOR TEMPERATURE CONTROL, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SW 1/4, SECTION 3, T 28 S, R 14 W, W.M.; 560 FEET SOUTH AND 1200 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 3.

The amount of water used for irrigation of cranberries under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. For any other crop, this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, (or its equivalent) and 2 1/2 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is described as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
