CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEORGE W. GORDON

confirms the right to use the waters of SOAP CREEK AND GORDON RESERVOIR, CONSTRUCTED UNDER PERMIT R-7823, a tributary of LUCKIAMUTE RIVER, for the purpose of IRRIGATION OF 42.9 ACRES.

This right has been perfected under Permit 44137. The date of priority is AUGUST 25, 1978. This right is limited to 0.54 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

POINT 1 - SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC, 64 SECTION 6, T 10 S, R 4 W, W.M.; 420 FEET NORTH AND 1050 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 6; POINT 2 - NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 65, SECTION 5, T 10 S, R 4 W, W.M.; 1840 FEET NORTH AND 1220 FEET EAST FROM THE EAST 1/4 CORNER OF SECTION 6.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second FROM DIRECT FLOW (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

NE 1/4 NW 1/4            10.0 ACRES  
NW 1/4 NW 1/4            25.6 ACRES  
BOTH AS PROJECTED WITHIN DLC 65  
SECTION 5

NE 1/4 NE 1/4            7.3 ACRES  
AS PROJECTED WITHIN DLC 65  
SECTION 6  
TOWNSHIP 10 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
