CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That L. E. THROOP

of Paulina State of Oregon has a right to the use of the waters of Powell, Tamarack, Roger Creeks, tributary to Crooked River, and spring on NW 1/4 of NE 1/4, Section Ten (10), Tp. 16 S. R. 25 E. W. M.

for the purpose of the irrigation of 498 acres of land, and stock and domestic use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 1, at page 449; that the priority of the right hereby confirmed dates from the year 1886 for the irrigation of 200 acres of land; from 1895 for the irrigation of 100 acres of land; and from 1905 for the irrigation of 198 acres of land;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed a reasonable amount for stock and domestic use, and 6.23 cubic feet per second from July 1st to September 15th of each year for irrigation. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

30 acres in the SW 1/4 of SE 1/4; 20 acres in the NE 1/4 of SW 1/4; 14 acres in the SE 1/4 of SW 1/4; 15 acres in the NW 1/4 of SE 1/4; Section Thirty-two (32): 30 acres in the SW 1/4 of SW 1/4; Section Thirty-three (33): all in Township Fifteen (15) South Range Twenty-five (25) East of Willamette Meridian: 22 acres in the NE 1/4 of SW 1/4; 15 acres in the SW 1/4 of SW 1/4; 19 acres in the SE 1/4 of SW 1/4; 2 acres in the NE 1/4 of SE 1/4; 24 acres in the NW 1/4 of SE 1/4; 40 acres in the SW 1/4 of SE 1/4; 32 acres in the SE 1/4 of SE 1/4; Section Four (4): 14 acres in the SW 1/4 of SW 1/4; Section Three (3): 40 acres in the NE 1/4 of NE 1/4; 20 acres in the NW 1/4 of NE 1/4; 20 acres in the SE 1/4 of NE 1/4; Section Nine (9): 20 acres in the NW 1/4 of NE 1/4; 21 acres in the NE 1/4 of NW 1/4; 40 acres in the NW 1/4 of NW 1/4; 35 acres in the SW 1/4 of NW 1/4; 25 acres in the SE 1/4 of NW 1/4; Section Ten (10), Township Sixteen (16) South Range Twenty five (25) East of Willamette Meridian, in Crook County, Oregon.

Note: The limited irrigation season set forth herein is in error and should conform to the season as defined in the Decree. See document filed adjacent to Certificate 513.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
