CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WARM SPRINGS CREEK, a tributary of POWDER RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 222.0 ACRES.

This right was perfected under Permit 50664. The date of priority is AUGUST 7, 1987. This right is limited to 5.55 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NW 1/4, SECTION 4, T 7 S, R 39 E, W.M.; 750 FEET SOUTH AND 320 FEET EAST FROM THE NW CORNER OF SECTION 4.

SW 1/4 SW 1/4, SECTION 33, T 6 S, R 39 E, W.M.; 40 FEET NORTH AND 620 FEET EAST FROM THE SW CORNER OF SECTION 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. When, in the judgment of the watermaster, it becomes necessary to provide water use for department management activities, the watermaster will provide a report on the use of water from this diversion and methods employed to use water more efficiently and conserve water.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
