CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of THREE MILE CREEK, a tributary of WHITE RIVER, for MAINTAINING CODY PONDS 1, 3, 4 AND 5 FOR FISH.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WASCO County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at Page 196. The date of priority is 1898.

The use is limited to 0.14 CUBIC FOOT PER SECOND TO JULY 1 OF EACH YEAR AND 0.07 CUBIC FOOT PER SECOND THEREAFTER DURING THE IRRIGATION SEASON, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 10, T 4 S, R 11 E, W.M.; 726 FEET SOUTH AND 528 FEET WEST FROM THE NE CORNER OF SECTION 10.

The amount of water used is limited to a diversion of 5.75 ACRE FEET DURING ANY 30 DAY PERIOD UP TO JULY 1ST OF EACH YEAR AND 17.25 ACRE FEET DURING ANY IRRIGATION SEASON.

A description of the place of use to which this right is appurtenant is as follows:



This certificate is issued to confirm changes in use, place of use, and point of diversion approved by orders of the Water Resources Director entered April 15, 1965 and June 26, 1978 approving transfer application O-40 and together with certificate 67112 supersedes certificate 17155, State Record of Water Right Certificates,

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
