CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THREE MILE IRRIGATION COOPERATIVE, INC.
THE DALLES, OREGON 97056

confirms the right to use the waters of A WELL in the COLUMBIA RIVER BASIN for IRRIGATING 179.64 ACRES.

This right was perfected under Permit U-175. The date of priority is DECEMBER 12, 1945. This right is limited to 2.994 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 38, SECTION 1, T 1 N,
R 13 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.



This certificate describes that portion of the water right confirmed by Certificate 20792, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered May 14, 1976, and February 3, 1992, canceling portions of said water right.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
