CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WEISHAAR FARMS
65011 OREGON HIGHWAY 237
LA GRANDE, OREGON 97850

confirms the right to use the waters of OLD and PRESENT CHANNELS OF THE GRANDE RONDE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATING 79.0 ACRES.

This right was perfected under Permit 31347. The date of priority is NOVEMBER 12, 1965. This right is limited to 1.29 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

PRESENT CHANNEL - SE 1/4 NW 1/4, SECTION 32, T 2 S, R 39 E, W.M.; 560 FEET NORTH AND 60 FEET WEST FROM THE CENTER 1/4 CORNER OF SECTION 32; OLD CHANNEL - SW 1/4 SE 1/4, SECTION 3, T 3 S, R 39 E, W.M.; 190 FEET NORTH AND 2640 FEET EAST FROM THE SW CORNER OF SECTION 3.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


NE 1/4 NW 1/4 39.6 ACRES
NW 1/4 NW 1/4 39.4 ACRES
SECTION 10
TOWNSHIP 3 SOUTH, RANGE 39 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 40955, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered FEBRUARY 6, 1992, canceling a portion of said water right.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
