CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALBERT AND ADELINE M. PONDELICK 1021 MISSOURI FLAT ROAD GRANTS PASS, OREGON 97526

confirms the right to use the waters of MILLER CREEK, a tributary of APPLEGATE RIVER, for the purpose of IRRIGATING 82.0 ACRES.

The right has been perfected under Permit 42951. The date of priority is FEBRUARY 22, 1978. The right is limited to not more than 1.03 CUBIC FEET PER SECOND, BEING 0.17 CFS FROM DIVERSION 1-A, 0.33 CFS FROM DIVERSION 1-B, AND 0.53 CFS FROM DIVERSION 2 or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 24, T 37 S, R 5 W, W.M.; 1A - 890 FEET NORTH AND 1210 FEET EAST; 1B - 30 FEET NORTH AND 1240 FEET EAST; BOTH FROM THE SOUTHWEST CORNER OF SECTION 24; SE 1/4 NW 1/4, SECTION 25, T 37 S, R 5 W, W.M.; 2 - 1600 FEET SOUTH AND 1400 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
