CERTIFICATE OF WATER RIGHT

FRED MESSERLE AND SONS, INC 2330 EAST CATCHING SLOUGH ROAD COOS BAY, OR 97420

confirms the right to use the waters of COQUILLE RIVER, a tributary of PACIFIC OCEAN, for IRRIGATION OF 132.0 ACRES, BARN WASHING, AND STOCK USE.

This right was perfected under Permit 41307. The date of priority is MARCH 29, 1976. This right is limited to 1.75 CUBIC FEET PER SECOND, BEING 1.65 CFS FOR IRRIGATION AND 0.1 CFS FOR BARN WASHING AND STOCK USE or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

1 - NE 1/4 NW 1/4, SECTION 3, T 28 S, R 13 W, W.M.; 200 FEET SOUTH AND 200 FEET WEST FROM THE NORTH 1/4 CORNER OF SECTION 3; 2 - NE 1/4 NE 1/4, SECTION 32, T 27 S, R 13 W, W.M.; 260 FEET SOUTH AND 300 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 32.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
