CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BEAVER SLOUGH DRAINAGE DISTRICT
C/O KEN MESSERLE
ROUTE 1, BOX 275
COQUILLE, OR 97423

confirms the right to use the waters of CHINA CAMP CREEK, WHEN AVAILABLE, WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM CHINA CAMP CREEK TO BE MADE UP BY APPROPRIATION FROM COQUILLE RIVER, a tributary of THE PACIFIC OCEAN, for IRRIGATING 1509.0 ACRES.

This right was perfected under Permit 40791. The date of priority is MARCH 30, 1976. This right is limited to 18.9 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, SECTION 27 AND NE 1/4 NE 1/4, SECTION 32, T 27 S,
R 13 W, W.M.; CREEK - 1740 FEET NORTH AND 850 FEET EAST FROM THE
SOUTHWEST CORNER OF SECTION 27; RIVER - 260 FEET SOUTH AND 300 FEET WEST
FROM THE NORTHEAST CORNER OF SECTION 32.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
