CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROCKY RIDGE RANCHES INC.  
ROUTE 3, BOX 280  
HILLSBORO, OREGON 97124

confirms the right to use the waters of LOST, BOULDER, AND FOREST CREEKS; AND RESERVOIR 4 CONSTRUCTED UNDER PERMIT R-7805, tributaries of WHITE RIVER, for PRIMARY IRRIGATION OF 292.4 ACRES FROM LOST, BOULDER, AND FOREST CREEKS, AND SUPPLEMENTAL IRRIGATION OF 208.8 ACRES FROM RESERVOIR 4.

This right was perfected under Permit 43971. The date of priority is NOVEMBER 15, 1977. This right is limited to 7.89 CUBIC FEET PER SECOND, BEING 2.63 CFS FROM EACH OF LOST, BOULDER, AND FOREST CREEKS FOR PRIMARY IRRIGATION ONLY; AND 9.1 ACRE-FEET STORED WATER ONLY FROM RESERVOIR 4, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversions are located as follows:

LOST CREEK - SE 1/4 SW 1/4, SECTION 26, T 4 S, R 10 E, W.M.; 1310 FEET NORTH AND 1740 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 26; BOULDER CREEK - NE 1/4 SE 1/4, SECTION 27, T 4 S, R 10 E, W.M.; 2340 FEET NORTH AND 350 FEET WEST FROM THE SOUTHEAST CORNER SECTION 27; FOREST CREEK - SW 1/4 SW 1/4, SECTION 27, T 4 S, R 10 E, W.M.; 195 FEET NORTH AND 256 FEET EAST FROM THE SOUTHWEST CORNER SECTION 27; RESERVOIR 4 - NE 1/4 NE 1/4, SECTION 7, T 5 S, R 12 E, W.M.; 700 FEET SOUTH AND 650 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 7.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
