CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THOMAS C. AND SUSAN M. SMITH, JR. P.O. BOX 156 AZALEA, OREGON 97410

confirms the right to use the waters of COW CREEK AND 3.8 ACRE-FEET FROM RESERVOIRS 1 AND 2 CONSTRUCTED UNDER PERMIT R-7255, a tributary of SOUTH UMPQUA RIVER, for the purpose of IRRIGATION OF 4.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 35.7 ACRES.

This right has been perfected under Permit 43055. The date of priority is DECEMBER 5, 1977. This right is limited to 0.06 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

1 - NE 1/4 SW 1/4, SECTION 33, 670 FEET SOUTH AND 200 FEET WEST; 2 - SE 1/4 SW 1/4, SECTION 33, 1500 FEET SOUTH AND 160 FEET WEST, COW CREEK - NW 1/4 SE 1/4, SECTION 33, 225 FEET SOUTH AND 450 FEET EAST, ALL FROM THE CENTER 1/4 CORNER OF SECTION 33, T 31 S, R 4 W, W.M.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SEVENTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
