CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RAYMOND D. AND CHRISTINE C. DODGE 7281 WILLIAMS HIGHWAY GRANTS PASS, OREGON 97527

confirms the right to use the waters of the APPLEGATE RIVER, a tributary of the ROGUE RIVER, for IRRIGATING 27.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at Page 523. The date of priority is 1903.

The use is limited to 0.55 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION: THE BUNCH AND SWINDEN DITCH, [SW 1/4 NE 1/4, SECTION 20, T 37 S, R 5 W, W.M.], or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 1 (SW 1/4 NW 1/4), SECTION 20, T 37 S, R 5 W, W.M.; 980 FEET NORTH AND 20 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 20.

A description of the place of use to which this right is appurtenant is as follows:

27.6 ACRES IN THE SE 1/4 NE 1/4 AND NE 1/4 SE 1/4, SECTION 19 AND SW 1/4 NW 1/4 AND NW 1/4 SW 1/4, SECTION 20, T 37 S, R 5 W, W.M.: BEING IN THAT PART OF THE FOLLOWING DESCRIBED PROPERTY LYING BELOW THE SWINDEN AND BUNCH DITCH:

Beginning at the SE corner of the SE 1/4 Section 19; running North 20 chains; East 14 chains; North 10.75 chains; West 7.20 chains; North 20 chains; West 10.10 chains; North 7.50 chains to the river; West 2.90 chains; South 61 chains; East 5.40 chains to the place of beginning, containing 61.66 acres, more or less, lying and being in Sections 19 and 20.

WHEN IN THE JUDGMENT OF THE WATERMASTER IT BECOMES NECESSARY TO INSTALL HEADGATES AND MEASURING DEVICES:

THAT THE DIVERSION WORKS SHALL INCLUDE AN IN-LINE FLOW METER, A WEIR, OR OTHER SUITABLE DEVICE FOR MEASURING THE WATER TO WHICH THE WATER USER IS ENTITLED;

THAT THE TYPE AND PLANS OF THE MEASURING DEVICE BE APPROVED BY THE WATERMASTER BEFORE THE BEGINNING OF CONSTRUCTION WORK AND THAT THE WEIR OR MEASURING DEVICE BE INSTALLED UNDER THE GENERAL SUPERVISION OF SAID WATERMASTER.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 1, 1985 and supersedes certificate 32851, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
