CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JACK CALDWELL
734 WEST DUTTON ROAD
EAGLE POINT, OREGON 97524

confirms the right to use the waters of LITTLE BUTTE CREEK, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 21.6 ACRES.

This right has been perfected under Permit 23271. The date of priority is SEPTEMBER 7, 1954. This right is limited to 0.27 CUBIC FOOT PER SECOND if available at the original point of diversion: NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 51, SECTION 8, T 36 S, R 1 W, W.M.; 1190 FEET SOUTH AND 380 FEET WEST FROM THE N 1/4 CORNER OF SECTION 8, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 51, SECTION 8, T 36 S, R 1 W, W.M.; 630 FEET SOUTH AND 500 FEET EAST FROM THE N 1/4 CORNER OF SECTION 8.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to the terms and conditions of stipulation recorded on pages 901 and 902, Volume 3, Miscellaneous Records of the Water Resources Director and by reference made a part hereof.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

SW 1/4 NE 1/4 10.9 ACRES
NW 1/4 SE 1/4 5.7 ACRES
BOTH AS PROJECTED WITHIN DLC 51
LOT 5 (NW 1/4 SE 1/4) 5.0 ACRES
SECTION 8
TOWNSHIP 36 SOUTH, RANGE 1 WEST, W.M.

The following provisions shall be effective when in the judgment of the watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water;

the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 29, 1978 and supersedes certificate 26933, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
