CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SKOOKUM SPRING, LAKE CAMP SPRING, DUNTEN SPRING, MCALLISTER SPRING, JUMP OFF TRAIL, CRIB SPRING, LOST SPRING, JUNIPER SPRING, BEAR SPRING, HAWK SPRING, LOWER ROCK SPRING, ROCK SPRING, WESTFALL SPRING, HOFFMAN SPRING, REFRIGERATOR 2, REFRIGERATOR 1, tributaries of the MALHEUR RIVER, for LIVESTOCK.

This right was perfected under Permit 50354. The date of priority is OCTOBER 11, 1983. This right is limited to 0.016 CUBIC FOOT PER SECOND, BEING 0.01 CFS FROM EACH SOURCE, PROVIDED THE TOTAL QUANTITY DIVERTED FROM ALL SOURCES DOES NOT EXCEED 0.016 CFS or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

- (1) NW 1/4 NW 1/4, SECTION 35, T 17 S, R 34 E, W.M.; 1200 FEET SOUTH & 1000 FEET EAST FROM THE NW CORNER OF SECTION 35.
- (2) SW 1/4 NE 1/4, SECTION 8, T 17 S, R 34 E, W.M.; 2200 FEET SOUTH & 1600 FEET WEST FROM THE NE CORNER OF SECTION 8.
- (3) SE 1/4 SE 1/4, SECTION 4, T 17 S, R 34 E, W.M.; 1300 FEET NORTH & 1300 FEET WEST FROM THE SE CORNER OF SECTION 4.
- (4) NW 1/4 SE 1/4, SECTION 3, T 17 S, R 34 E, W.M.; 2000 FEET NORTH & 1900 FEET WEST FROM THE SE CORNER OF SECTION 3.
- (5) NE 1/4 NE 1/4, SECTION 28, T 17 S, R 34 E, W.M.; 1100 FEET SOUTH & 700 FEET WEST FROM THE NE CORNER OF SECTION 28.
- (6) NW 1/4 SE 1/4, SECTION 25, T 17 S, R 34 E, W.M.; 2100 FEET NORTH & 2500 FEET WEST FROM THE SE CORNER OF SECTION 25.
- (7) NE 1/4 SE 1/4, SECTION 25, T 17 S, R 34 E, W.M.; 2600 FEET NORTH & 1100 FEET WEST FROM THE SE CORNER OF SECTION 25.
- (8) SW 1/4 SE 1/4, SECTION 24, T 17 S, R 34 E, W.M.; 200 FEET NORTH & 1400 FEET WEST FROM THE SE CORNER OF SECTION 24.
- (9) NW 1/4 SE 1/4, SECTION 23, T 17 S, R 34 E, W.M.; 1900 FEET NORTH & 2200 FEET WEST FROM THE SE CORNER OF SECTION 23.
- (10) SW 1/4 SW 1/4, SECTION 23, T 17 S, R 34 E, W.M.; 100 FEET NORTH & 500 FEET EAST FROM THE SW CORNER OF SECTION 23.
- (11) SE 1/4 NW 1/4, SECTION 21, T 17 S, R 34 E, W.M.; 3100 FEET NORTH & 2200 FEET EAST FROM THE SW CORNER OF SECTION 21.

(12) NE 1/4 NW 1/4, SECTION 21, T 17 S, R 34 E, W.M.; 1000 FEET SOUTH & 2500 FEET WEST FROM THE NW CORNER OF SECTION 21.

(13) SW 1/4 SE 1/4, SECTION 36, T 17 S, R 34 E, W.M.; 1300 FEET NORTH & 1900 FEET WEST FROM THE SE CORNER OF SECTION 36.

(14) NE 1/4 NW 1/4, SECTION 36, T 17 S, R 34 E, W.M.; 500 FEET SOUTH & 1800 FEET EAST FROM THE NW CORNER OF SECTION 36.

(15) SW 1/4 NE 1/4, SECTION 35, T 17 S, R 34 E, W.M.; 2200 FEET SOUTH & 2100 FEET WEST FROM THE NE CORNER OF SECTION 35.

(16) SW 1/4 NE 1/4, SECTION 35, T 17 S, R 34 E, W.M.; 1700 FEET SOUTH & 2000 FEET WEST FROM THE NE CORNER OF SECTION 35.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
