CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CORA KLINGER
767 OAK STREET
ASHLAND, OREGON 97520

confirms the right to use the waters of ASHLAND CREEK, a tributary of BEAR CREEK, for the purpose of IRRIGATION OF 2.5 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 13. The date of priority is 1886.

The right is limited to not more than 0.07 CUBIC FOOT PER SECOND.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 4, T 39 S, R 1 E, W.M.; 910 FEET SOUTH AND 820 FEET WEST FROM THE CENTER 1/4 CORNER OF SECTION 4.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SE 1/4 0.2 ACRE
AS PROJECTED WITHIN DLC 40
SECTION 4

NE 1/4 SE 1/4 2.3 ACRES

The following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the water user is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 28, 1978, and supersedes Certificate 16040, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
