## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BETTY FULLETON ROUTE 2, BOX 37A ECHO, OREGON 97826

confirms the right to use the waters of A SUMP in the UMATILLA RIVER BASIN for the purpose of IRRIGATING 49.2 ACRES.

The right has been perfected under Permit G-10. The date of priority is APRIL 6, 1955. The right is limited to not more than 0.34 CUBIC FOOT PER SECOND IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION BEING WITHIN THE SE 1/4 SW 1/4, SECTION 31, T 3 N, R 30 E, W.M.; 275 FEET NORTH AND 15 FEET WEST FROM THE SOUTH QUARTER CORNER OF SECTION 31 or its equivalent in case of rotation, measured at the well.

The sump is located as follows:

LOT 3 (NE 1/4 NW 1/4), SECTION 6, T 2 N, R 30 E, W.M.; 290 FEET SOUTH AND 1080 FEET WEST FROM THE NORTH 1/4 CORNER OF SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4 14.6 ACRES SW 1/4 SE 1/4 7.2 ACRES

SECTION 31 TOWNSHIP 3 NORTH, RANGE 30 EAST, W.M.

LOT 3 (NE 1/4 NW 1/4) 27.4 ACRES SECTION 6 TOWNSHIP 2 NORTH, RANGE 30 EAST, W.M.

When in the judgment of the Watermaster it becomes necessary to install measuring devices:

The pump system shall include an in-line flow meter or other suitable device for measuring the water to which the applicant is entitled;

The type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

At such time as distribution of water from the Umatilla River becomes necessary, water from the authorized point of appropriation will be distributed as surface water.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MARCH 19, 1987 and supersedes certificate 26079, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
