CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MILLARD F. HARTLEY  
3643 SCOTT ROAD  
HOOD RIVER, OREGON 97031

confirms the right to use the waters of SPRING BRANCH, a tributary of NEAL CREEK, for IRRIGATION AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for HOOD RIVER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 469. The date of priority is AUGUST, 1896.

The use is limited to 0.45 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source AND SHALL BE SUBJECT TO ALL OTHER CONDITIONS AND LIMITATIONS IN SAID DECREE.

The original point of diversion was located as follows:

SE 1/4 SW 1/4, SECTION 25, T 2 N, R 10 E, W.M.; 480 FEET NORTH AND 300 FEET WEST FROM THE S 1/4 CORNER OF SECTION 25.

The point of diversion is located as follows:

SPRING - 195 FEET SOUTH AND 855 FEET WEST FROM THE N 1/4 CORNER OF SECTION 36, T 2 N, R 10 E, W.M.

The quantity of water diverted at the new point of diversion shall not exceed 0.45 cubic foot per second and that the quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available at the old (original) point of diversion under the subject right.

The following provisions will be effective when in the judgement of the Watermaster it becomes necessary to install headgates and measuring devices:

The diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the water user is entitled;

The type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 SW 1/4      22.0 ACRES  
SECTION 25

NE 1/4 NW 1/4      14.0 ACRES  
SECTION 36  
TOWNSHIP 2 NORTH, RANGE 10 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 17, 1989, AND TOGETHER WITH CERTIFICATE 67241 supersedes Certificate 3844, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
