CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN RUEDY IRRIGATION DITCH COMPANY  
CECIL, OREGON

confirms the right to use the waters of WILLOW CREEK, a tributary of COLUMBIA, for IRRIGATION OF 56.89 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for MORROW County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 73. The date of priority is NOVEMBER, 1896, AND DECEMBER 28, 1908.

The use is limited to 0.95 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

WILFRED CECIL DITCH AND JOHN RUEDY COMPANY DITCH NO. 2

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 185 $\frac{1}{2}$ , State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MARCH 20, 1992, approving Transfer Application 6228.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
