CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WOLF RUN WATER USERS ASSOCIATION
807 EAST 18th STREET.
THE DALLES, OREGON 97058

confirms the right to use the waters of TAMARACK CREEK, SPRINGS AND GULCH, AND EIGHT MILE CREEK, tributary of the COLUMBIA RIVER, for IRRIGATION OF 135.3 ACRES, DOMESTIC, AND STOCK USE.

This right was perfected under Permits 92 and 93. The date of priority is MAY 3, 1909. This right is limited to 1.766 CUBIC FOOT PER SECOND, BEING 1.69 cfs FOR IRRIGATION and 0.076 cfs FOR DOMESTIC AND STOCK USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is the WOLF RUN DITCH.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 35096, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered October 29, 1985, June 27, 1985, August 21, 1985, and March 20, 1992, approving Transfer Applications 5633, 5639, 5664, and 6048.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
