CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WM. SMITH
PRINEVILLE, OREGON 97754

confirms the right to use the waters of MILL CREEK, a tributary of CROOKED RIVER, for IRRIGATION 119.5 ACRES AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for CROOK County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 449. The date of priority is 1870.

The use is limited to A REASONABLE AMOUNT FOR STOCK AND 1.494 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 14 SOUTH, RANGE 17 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 661, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MARCH 25, 1992, approving Transfer Application 6664.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
