CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CARL I. VISTICA 14271 WILCO HIGHWAY NE WOODBURN, OREGON 97071

confirms the right to use the waters of PUDDING RIVER, a tributary of WILLAMETTE RIVER, for IRRIGATION OF 21.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 39.4 ACRES.

This right was perfected under Permit 49880. The date of priority is SEPTEMBER 18, 1986. This right is limited to 0.76 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 21, T 5 S, R 1 W, W.M.; 3560 FEET NORTH AND 1810 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 21.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. Provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that although declared herein to be for supplemental irrigation in part the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
