This right has been perfected under Permit 48116. The date of priority is AUGUST 3, 1983. This right is limited to 5.8 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows: NE 1/4 SE 1/4, SECTION 35, T 1 S, R 25 E, W.M.; 1550 FEET NORTH AND 640 FEET WEST FROM THE SE CORNER OF SECTION 35. The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, shall be limited to a ONE-SIXTIETH of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that although declared herein to be for supplemental irrigation in part the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein.
