CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of EAST DAIRY CREEK, a tributary of DAIRY CREEK, for the purpose of IRRIGATING 30.0 ACRES.

This right has been perfected under Permit 22299. The date of priority is MAY 28, 1953. This right is limited to 0.37 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 40, SECTION 34, T 2 N, R 3 W, W.M.; 750 FEET SOUTH AND 1440 FEET WEST FROM THE NORTHEAST CORNER OF DLC 40.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

NE 1/4 SE 1/4 4.4 ACRES
NW 1/4 SE 1/4 10.3 ACRES
SW 1/4 SE 1/4 6.4 ACRES
SE 1/4 SE 1/4 8.9 ACRES
ALL AS PROJECTED WITHIN DLC 45
SECTION 35
TOWNSHIP 2 NORTH, RANGE 3 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered APRIL 3, 1987 and supersedes Certificate 28380, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
