confirms the right to use the waters of POWDER RIVER, a tributary of SNAKE RIVER, for IRRIGATION OF 80.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The date of priority is 1895 FOR LANDS IN TRACT 2.

The use is limited to that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to AN AMOUNT ACTUALLY BENEFICIALLY USED FOR SAID PURPOSES, AND SHALL NOT EXCEED 1/40 OF ONE CUBIC FOOT PER SECOND PER ACRE, measured at the point of diversion. IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION IN THE SW 1/4 NW 1/4, SECTION 16, T 9 S, R 40 E, W.M.; BALDOCK DITCH - 1760 FEET SOUTH AND 360 FEET EAST FROM THE NW CORNER OF SECTION 16 and shall be subject to all other conditions and limitations contained in THE POWDER RIVER DECREE, Page 291, Volume 6.

The point of diversion is located as follows:

SW 1/4 NW 1/4, SECTION 9, T 9 S, R 40 E, W.M.; CORRAL DITCH - 50 FEET NORTH AND 2720 FEET EAST FROM THE CENTER 1/4 CORNER OF SECTION 8.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SE 1/4 40.0 ACRES NW 1/4 SE 1/4 40.0 ACRES SECTION 3 TOWNSHIP 9 SOUTH, RANGE 40 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 13, 1979, and together with Certificate of water right 48925, supersedes Certificate 4457.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
