confirms the right to use the waters of A WELL, a tributary of STAGE GULCH, for IRRIGATION OF 382.5 ACRES.

This right was perfected under Permit G-7965. The date of priority is MAY 23, 1977. This right is limited to 4.78 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SW 1/4, SECTION 26, T 4 N, R 30 E, W.M.; 2640 FEET NORTH AND 30 FEET EAST FROM THE SW CORNER OF SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
