CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

M3X, INC. AND NEAL AND ROSE MADDY 1207 9TH SE ALBANY, OREGON 97321

confirms the right to use the waters of A WELL in the CALAPOOIA RIVER BASIN for IRRIGATING 7.7 ACRES.

This right was perfected under Permit G-3364. The date of priority is JULY 11, 1966. This right is limited to 0.097 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well. The quantity of water appropriated at the new well, shall not exceed 0.097 CUBIC FOOT PER SECOND and that the quantity of water appropriated at the new well together with that appropriated from the old well shall not exceed the quantity of water available at the original well under the subject right.

The well is located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 77, SECTION 24, T 11 S, R 4 W, W.M.; 1861 FEET SOUTH AND 1456 FEET EAST FROM THE NW CORNER OF DLC 77.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

When in the judgement of the watermaster it becomes necessary to install measuring devices:

the pump system shall include an access port for measuring the water level;

the pump system shall include an in-line flow meter or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered FEBRUARY 27, 1989, and together with Certificate 60945, supersedes Certificate 37741, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
