CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PAULINA RANCH, INC.
P.O. BOX 46
PAULINA, OREGON 97751

confirms the right to use the waters of WELL 1 in the BEAVER CREEK BASIN for IRRIGATION OF 89.9 ACRES.

This right was perfected under Permit G-9256. The date of priority is MAY 29, 1980. This right is limited to 1.12 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 4, T 17 S, R 23 E, W.M.; 2250 FEET SOUTH AND 1420 FEET WEST FROM THE NE CORNER OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 17 SOUTH, RANGE 23 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 61101, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered May 4, 1992, approving Transfer Application 6489.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
