CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL in the CHEWAUCAN RIVER BASIN for IRRIGATION OF 107.0 ACRES.

This right was perfected under Permit G-8099. The date of priority is APRIL 10, 1978. This right is limited to 1.34 CUBIC FEET PER SECOND or its equivalent, IF AVAILABLE AT THE ORIGINAL WELL LOCATED AT: NE 1/4 SW 1/4, SECTION 30, T 35 S, R 21 E, W.M.; 2000 FEET NORTH AND 1660 FEET EAST FROM THE SW CORNER OF SECTION 30, in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 SW 1/4, SECTION 19, T 35 S, R 21 E, W.M.; 30 FEET NORTH AND 1000 FEET EAST FROM THE SW CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

When in the judgment of the Watermaster it becomes necessary to install measuring devices:

the pump system shall include an in line flow meter or other suitable device for measuring the water to which the user is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered NOVEMBER 2, 1984, and supersedes Certificate 51595, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
