CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES F. AND LURLINE COONAN  
C-2 CATTLE COMPANY  
LAKE CREEK, OREGON 97524

confirms the right to use the waters of LONG CANYON, a tributary of NORTH FORK LITTLE BUTTE CREEK, for IRRIGATING 87.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 14, at Page 498. The date of priority is 1879.

The right is limited to 1.5 cubic feet per second, if available at the original point of diversion: SE 1/4 SE 1/4, SECTION 23, T 36 S, R 2 E, W.M.; LONG CANYON DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, SECTION 23, T 36 S, R 2 E, W.M.; WASSON CANYON DELIVERY CANAL - 120 FEET NORTH AND 950 FEET WEST FROM THE E 1/4 CORNER OF SECTION 23.

The amount of water used for irrigation under this right is limited to a diversion of ONE-SIXTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered MAY 4, 1990, and together with certificates 64234, 67332, AND 67330 supersedes certificate 33676, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
