CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES F. AND LURLINE COONAN  
C-2 CATTLE COMPANY  
LAKE CREEK, OREGON 97524

confirms the right to use the waters of SALT CREEK, YEW CREEK, AND WADE RESERVOIR CONSTRUCTED UNDER PERMIT R-1716, a tributary of LITTLE BUTTE CREEK, for the purpose of IRRIGATING 5.0 ACRES.

This right was perfected under Permit 23418. The date of priority is MAY 31, 1955. This right is limited to 0.06 CUBIC FOOT PER SECOND BEING 0.03 CFS FROM SALT CREEK AND 0.03 CFS FROM YEW CREEK or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NE 1/4, SECTION 11, SW 1/4 SE 1/4, SECTION 10, T 36 S, R 2 E, W.M.; SALT CREEK - 710 FEET SOUTH AND 850 FEET EAST; YEW CREEK - 1100 FEET SOUTH AND 790 FEET EAST BOTH FROM THE N 1/4 CORNER OF SECTION 11, RESERVOIR - 1020 FEET NORTH AND 2540 FEET WEST FROM THE SE CORNER OF SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second from direct flow (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4    1.7 ACRES  
SECTION 15

SE 1/4 NE 1/4    3.3 ACRES  
SECTION 16

TOWNSHIP 36 SOUTH, RANGE 2 EAST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered DECEMBER 18, 1968, and together with certificate 35909, supersedes certificate 35227, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
