CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RON TANKERSLEY P.O. BOX 219 NORTH PLAINS, OREGON 97133

confirms the right to use the waters of A RESERVOIR ENLARGED UNDER PERMIT R-7803, a tributary of TUALITY CREEK, for the purpose of the SUPPLEMENTAL IRRIGATION OF 267.2 ACRES.

This right has been perfected under Permit 43958. The date of priority is MAY 5, 1978. This right is limited to 4.12 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 60, SECTION 34, T 1 S, R 2 W, W.M.; 490 FEET NORTH AND 800 FEET WEST FROM THE SE CORNER OF SECTION 34.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 2.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
