CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WIL WILSON 17900 MALLARD LANE SE DAYTON, OREGON 97114

confirms the right to use the waters of THE WILLAMETTE RIVER BY DIVERSION FROM ADJACENT GRAVEL PITS, a tributary of COLUMBIA RIVER, for IRRIGATION OF 32.0 ACRES.

This right was perfected under Permit 51093. The date of priority is APRIL 26, 1990. This right is limited to 0.4 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 26, T 4 S, R 3 W, W.M.; 900 FEET SOUTH AND 2270 FEET EAST FROM NW CORNER OF LOT 13.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

USE OF WILLAMETTE RIVER WATER BY A DIVERSION FROM ADJACENT GRAVEL PITS IS LIMITED TO APPROPRIATION OF DIRECT FLOW OF THE WATERS OF WILLAMETTE RIVER. THE USE IS LIMITED TO APPROPRIATION ONLY TO THE EXTENT THAT IT DOES NOT INTERFERE WITH THE RIGHT TO THE USE OF GROUND WATER BY OTHERS.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
