CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRIDAY FARMS INC.

confirms the right to use the waters of FERRY CREEK, a tributary of COQUILLE RIVER, for the purpose of IRRIGATING 5.6 ACRES.

The right has been perfected under Permit 17380. The date of priority is AUGUST 28, 1946. The right is limited to 0.42 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SW 1/4, SECTION 29, T 28 S, R 14 W, W.M.; 500 FEET SOUTH AND 290 FEET EAST FROM THE W 1/4 CORNER OF SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-tenth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 0.75 acre-foot for each acre irrigated in any 30-day period and shall be still further limited to a diversion of not to exceed 6 acre feet per acre during the irrigation season of each year, and for the irrigation of any other crop, it shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre foot per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:


SW 1/4 NW 1/4 5.6 ACRES  
SECTION 29  
TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 19, 1982, and a PARTIAL CANCELLATION ORDER APPROVED BY THE DIRECTOR ON OCTOBER 11, 1989, and supersedes Certificate 21441, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
