CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRIDAY FARMS INC.  
P.O. BOX 1384  
BANDON, OREGON 97411

confirms the right to use the waters of FERRY CREEK, a tributary of COQUILLE RIVER, for the purpose of SUPPLEMENTAL IRRIGATION, TEMPERATURE CONTROL, AND CRANBERRY HARVESTING OF 15.0 ACRES.

The right has been perfected under Permit 33423. The date of priority is MARCH 15, 1968. The right is limited to not more than 1.0 CUBIC FOOT PER SECOND, BEING 0.375 CFS FOR SUPPLEMENTAL IRRIGATION, 1.0 CFS FOR TEMPERATURE CONTROL AND 0.75 CFS FOR CRANBERRY HARVESTING, or its equivalent in case of rotation, measured at the point of diversion from the source. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right which was located in the NW 1/4 SW 1/4, SECTION 29, T 28 S, R 14 W, W.M.; 2940 FEET SOUTH AND 310 FEET EAST FROM THE NW 1/4 CORNER OF SECTION 29.

The point of diversion is located as follows:

NW 1/4 SW 1/4, SECTION 29, T 28 S, R 14 W, W.M.; 500 FEET SOUTH AND 290 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for irrigation of any other crop, this appropriation shall be limited to ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 NW 1/4 15.0 ACRES  
SECTION 29  
TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.

When in the judgment of the watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water;

the type and plans of the measuring device be approved by the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JANUARY 19, 1982 and supersedes certificate 39516, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
