confirms the right to use the waters of WELLS 1 AND 2 in the TUALITY CREEK BASIN for the purposes of THE IRRIGATION OF 48.4 ACRES AND INDUSTRIAL USE.

The right has been perfected under Permit G-2485. The date of priority is JUNE 25, 1963. The right is limited to not more than 0.43 CUBIC FOOT PER SECOND BEING 0.33 CFS FROM WELL 1 FOR IRRIGATION AND 0.10 CFS FROM WELL 2 FOR INDUSTRIAL USE IF AVAILABLE AT OLD WELL LOCATED AT 1315 FEET SOUTH AND 70 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 29, BEING WITHIN THE NE 1/4 NE 1/4 OF SECTION 29, TOWNSHIP 1 SOUTH, RANGE 1 WEST, W.M. measured at the wells.

The wells are located as follows:

SE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 60, SECTION 34; LOT 1 (SW 1/4 NE 1/4), SECTION 33, T 1 S, R 2 W, W.M.; WELL 1 - 800 FEET NORTH AND 130 FEET WEST FROM THE SE CORNER OF SECTION 34; WELL 2 - 850 FEET SOUTH AND 700 FEET WEST FROM THE SW CORNER OF DLC 54.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in USE, PLACE OF USE, AND POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MARCH 19, 1987, and supersedes Certificate 34941, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
