CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GOOSE BAY FARMS 26800 MODOC POINT ROAD CHILOQUIN, OREGON 97624

confirms the right to use the waters of UPPER KLAMATH LAKE, a tributary of KLAMATH RIVER, for the purpose of IRRIGATING 322.7 ACRES.

The right has been perfected under Permit 46244. The date of priority is JUNE 23, 1981. The right is limited to not more than 5.78 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, SECTION 8, T 36 S, R 7 E, W.M.; 1360 FEET SOUTH AND 2480 FEET WEST FROM THE NE CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
