CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of SOUTH FORK LITTLE BUTTE CREEK WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM SOUTH FORK LITTLE BUTTE CREEK TO BE MADE UP BY APPROPRIATION FROM NORTH FORK LITTLE BUTTE CREEK AND EL ROBLE ORCHARD RESERVOIR, CONSTRUCTED UNDER PERMIT R-10829, for TEMPERATURE CONTROL (FROST PROTECTION) OF 76.9 ACRES.

This right was perfected under Permit 50021. The date of priority is JANUARY 28, 1987. This right is limited to 7.5 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SOUTH FORK LITTLE BUTTE CREEK - NE 1/4 SE 1/4, SECTION 29, T 36 S, R 2 E, W.M.; 600 FEET SOUTH AND 525 FEET WEST FROM THE E 1/4 CORNER OF SECTION 29.

NORTH FORK LITTLE BUTTE CREEK - SE 1/4 NE 1/4, SECTION 20, T 36 S, R 2 E, W.M.; 60 FEET NORTH AND 630 FEET WEST FROM THE E 1/4 CORNER OF SECTION 20.

RESERVOIR - NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 90, SECTION 33, T 37 S, R 2 W, W.M.; 2970 FEET NORTH AND 940 FEET WEST FROM THE SE CORNER OF DLC 92.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
