CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LINCOLN HORIZONS, INC.

confirms the right to use the waters of RICKREALL CREEK AND RESERVOIRS 2 AND 3 CONSTRUCTED UNDER PERMIT R-10894, for RECREATION AND IRRIGATION OF 18.2 ACRES.

THE RIGHT ALLOWED HEREIN SHALL NOT PROVIDE FOR THE USE OF WATER FROM RICKREALL CREEK DURING THE PERIOD JULY 31 THROUGH SEPTEMBER 30, OF EACH YEAR.

This right was perfected under Permit 50184. The date of priority is SEPTEMBER 25, 1987 FOR USE OF 0.23 CUBIC FOOT PER SECOND FROM RICKREALL CREEK AND STORED WATER, AND DECEMBER 2, 1987 FOR USE OF 0.014 CFS FROM RICKREALL CREEK FOR RECREATION. This right is limited to 0.244 CUBIC FOOT PER SECOND, BEING 0.014 CFS FROM RICKREALL CREEK FOR MAINTAINING RESERVOIRS 2 AND 3 FOR RECREATION, AND 0.23 CFS FROM RICKREALL CREEK FOR IRRIGATION OF 18.2 ACRES or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 63, SECTION 35, T 7 S, R 5 W, W.M.; 390 FEET SOUTH AND 420 FEET EAST FROM THE NE CORNER OF DLC 66.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
