## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CARL A. ROSS, JR. 465 ROSS WICKS ROAD NORTH BEND, OREGON 97459

confirms the right to use the waters of THREE UNNAMED STREAMS, a tributary of NORTH SLOUGH, for DOMESTIC USE FOR TWO FAMILIES, STOCK WATERING, AND IRRIGATING 26.8 ACRES.

This right was perfected under Permit 50602. The date of priority is APRIL 1, 1988, FOR DOMESTIC AND STOCK AND JUNE 9, 1988, FOR IRRIGATION. This right is limited to 0.4462 CUBIC FOOT PER SECOND, BEING 0.0025 CFS FOR DOMESTIC FROM STREAM 1, 0.0062 CFS FOR LIVESTOCK AND 0.025 CFS FOR IRRIGATION FROM STREAM 2, AND 0.425 CFS FOR IRRIGATION FROM STREAM 3 or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

# STREAM NO. 1:

(1) SW 1/4 SW 1/4, SECTION 36, T 23 S, R 13 W, W.M.; SOUTH 62 FEET;

## STREAM NO. 2:

(2) SOUTH 36 DEGREES EAST 132 FEET; BOTH FROM THE SOUTH SIXTEENTH CORNER COMMON TO SECTIONS 35 AND 36;

## STREAM NO. 3:

- (3) NE 1/4 NW 1/4; NORTH 42 DEGREES EAST 2700 FEET;
- (4) SE 1/4 NW 1/4; NORTH 59 DEGREES EAST 1540 FEET; (5) SW 1/4 NW 1/4; NORTH 82 DEGREES EAST 1160 FEET; (6) SW 1/4 SW 1/4; SOUTH 40 DEGREES EAST 1740 FEET;

- (7) SE 1/4 SW 1/4; SOUTH 39 DEGREES EAST 2680 FEET; ALL FROM THE WEST QUARTER CORNER OF SECTION 36.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
