CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GREATER TACOMA COMMUNITY FOUNDATION
917 PACIFIC AVENUE #417
TACOMA, WASHINGTON 98402

confirms the right to use the waters of CROOKED RIVER, a tributary of
DESCHUTES RIVER, for IRRIGATION OF 44.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of
Oregon for CROOK County. The decree is of record at Salem, in the Order
Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 449. The
date of priority is APRIL 24, 1909.

The use is limited to 0.55 CUBIC FOOT PER SECOND or its equivalent in
case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 18, T 16 S, R 16 E, W.M.; 445 FEET NORTH AND
2550 FEET EAST FROM THE W $\frac{1}{4}$ CORNER OF SECTION 18.

A description of the place of use to which this right is appurtenant is
as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$	22.8 ACRES
SW $\frac{1}{4}$ NW $\frac{1}{4}$	0.3 ACRE
SE $\frac{1}{4}$ NW $\frac{1}{4}$	16.6 ACRES
NE $\frac{1}{4}$ SE $\frac{1}{4}$	4.1 ACRES
NW $\frac{1}{4}$ SE $\frac{1}{4}$	0.2 ACRE

SECTION 18
TOWNSHIP 16 SOUTH, RANGE 16 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION
approved by an order of the Water Resources Director entered JANUARY 18,
1979, approving Transfer M-202; describes that portion of the water
right NOT cancelled or lost by the provisions of orders of the Water
Resources Director entered January 18, 1979 and July 6, 1992, and order
of the Hearings Referee entered April 2, 1992; and supersedes
Certificate 586, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status
of the water right in regard to the provisions of ORS 540.610 pertaining
to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to
beneficial use on the lands or place of use described and is subject to
all other conditions and limitations contained in said decree.
