CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the SPRAGUE RIVER BASIN for IRRIGATING 251.8 ACRES.

This right was perfected under Permit G-10079. The date of priority is JUNE 16, 1982. This right is limited to 3.15 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 SW 1/4, SECTION 23, T 36 S, R 11 E, W.M.; 640 FEET NORTH AND 1160 FEET EAST FROM SOUTHWEST CORNER OF SECTION 23.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right herein granted shall be subject to prior rights to appropriate groundwater from the ground water reservoir which serves as the source of the appropriation authorized herein.

Should it be determined subsequent to the issuance of this certificate that the appropriation of ground water herein authorized has a measurable effect on the flow of WHISKEY CREEK AND/OR ITS TRIBUTARIES, the appropriation of ground water herein authorized shall be regulated in accord with prior rights to appropriate such surface water flow.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
