CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R. A. EMMITT KLAMATH FALLS, OREGON 97601

confirms the right to use the waters of KLAMATH RIVER, a tributary of KLAMATH LAKE, for IRRIGATION 372.6 ACRES.

This right was perfected under Permit 2969. The date of priority is JUNE 13, 1916. This right is limited to 4.66 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 34, T 39 S, R 8 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:
