CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R. A. EMMITT
KLAMATH FALLS, OREGON 97601

confirms the right to use the waters of KLAMATH RIVER, a tributary of KLAMATH LAKE, for IRRIGATION 372.6 ACRES.

This right was perfected under Permit 2969. The date of priority is JUNE 13, 1916. This right is limited to 4.66 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 34, T 39 S, R 8 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 2049, Volume 3, State Record of Water Right Certificates, NOT changed from primary irrigation to supplemental irrigation by the provisions of an order of the Water Resources Director entered on April 3, 1984 and together with 67638 supersedes Certificate 2049.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
