## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON DIVISION OF STATE LANDS 775 SUMMER STREET NE SALEM, OREGON 97310

confirms the right to use the waters of ONE WELL in the WILLAMETTE RIVER BASIN for IRRIGATING 53.2 ACRES.

This right was perfected under Permit G-11022. The date of priority is FEBRUARY 28, 1990. This right is limited to 0.67 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 NW 1/4, SECTION 21, T 6 S, R 3 W, W.M.; 700 FEET SOUTH AND 3790 FEET WEST FROM THE NE CORNER OF SECTION 21.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

> NE 1/4 SW 1/4 6.2 ACRES SW 1/4 SW 1/4 0.1 ACRE SE 1/4 SW 1/4 36.8 ACRES SW 1/4 SE 1/4 3.2 ACRES SECTION 16

> NE 1/4 NW 1/4 6.4 ACRES NW 1/4 NW 1/4 0.5 ACRE SECTION 21

TOWNSHIP 6 SOUTH, RANGE 3 WEST, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the department, the permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The Director may require water level or pump test results every ten years.
