CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN A. AND DEBORAH J. NIERADZIK
13548 TYEE ROAD
UMPQUA, OREGON 97486

confirms the right to use the waters of UMPQUA RIVER, a tributary of PACIFIC OCEAN, for IRRIGATION OF 4.2 ACRES.

This right was perfected under Permit 36825. The date of priority is MARCH 23, 1972. This right is limited to 0.052 CUBIC FOOT PER SECOND IF AVAILABLE AT OLD POINT OF DIVERSION LOCATED AT NE 1/4 SE 1/4, SECTION 31, T 24 S, R 7 W, W.M., 870 FEET SOUTH AND 400 FEET WEST FROM THE E 1/4 CORNER OF SECTION 31 or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 5 (NE 1/4 SE 1/4), SECTION 31, T 24 S, R 7 W, W.M.; 775 FEET SOUTH AND 440 FEET WEST FROM THE E 1/4 CORNER OF SECTION 31.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 6 (NE 1/4 SE 1/4)	1.7 ACRES
SECTION 31	
NW 1/4 SW 1/4	2.5 ACRES
SECTION 32	
TOWNSHIP 24 SOUTH, RANGE 7 WEST, W.M.	

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 6, 1983, and together with Certificate 51967, supersedes Certificate 43136, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
