CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

G. W. HAKE  
ASHLAND, OREGON 97520

confirms the right to use the waters of ASHLAND CREEK, a tributary of BEAR CREEK, for IRRIGATION OF 0.189 ACRE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 1. The date of priority is 1858.

The use is limited to 0.005 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

HELMAN DITCH FROM A POINT LOCATED WITHIN THE NW 1/4 NW 1/4,  
SECTION 9, T 39 S, R 1 E, W.M.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 SW 1/4 0.189 ACRE  
SECTION 4  
TOWNSHIP 39 SOUTH, RANGE 1 EAST, W.M.

Beginning on East line of O.&C.R.R. right of way, whence NW Corner of DLC 40, T 39 S, R 1 E, W.M., bears North 34 degrees 6 minutes West 818.65 feet; thence South 89 degrees 57 minutes East 489.50 feet; South 13 degrees 15 minutes West 279.5 feet; North 63 degrees 45 minutes West 205.65 feet; South 60 degrees 57 minutes West 92.2 feet to said right of way; North 34 degrees 45 minutes West 177.5 feet; North 36 degrees 19 minutes West 100 feet to beginning; containing 1.95 acres.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 16011, Volume 13, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered on March 25, 1985, approving 67624, and on August 13, 1985, approving 67623.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
