CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MICHAEL J. AND J. CHARLES MCAULIFFE

MALIN, OREGON 97632

confirms the right to use the waters of A WELL in the KLAMATH BASIN for IRRIGATING 52.3 ACRES.

This right was perfected under Permit G-3104. The date of priority is FEBRUARY 23, 1966. This right is limited to 0.65 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 NE 1/4, SECTION 33, T 40 S, R 12 E, W.M.; 1300 FEET SOUTH AND 380 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 33.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.50 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 40 SOUTH, RANGE 12 EAST, W.M.

The following provisions shall be effective when in the judgement of the Watermaster it becomes necessary to install measuring devices:

the pump system shall include an access port for measuring the water level;

the pump system shall include an in-line flow meter or other suitable device for measuring the water to which the user is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered OCTOBER 26, 1981, and together with Certificate 50383, supersedes Certificate 36946, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
