CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WARD AND GEORGINE CADWALLADER P.O. BOX 373 SHADY COVE, OR 97539

confirms the right to use the waters of THE ROGUE RIVER, a tributary of THE PACIFIC OCEAN, for IRRIGATING 0.93 ACRE.

This right was perfected under Permit 12635. The date of priority is MAY 7, 1937. This right is limited to 0.01 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source. IF AVAILABLE AT ORIGINAL POINT OF DIVERSION: LOT 1 (SE 1/4 NW 1/4), SECTION 15, T 34 S, R 1 W, W.M.; 340 FEET NORTH AND 3240 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 15.

The point of diversion is located as follows:

LOT 1 (SE 1/4 NW 1/4), SECTION 15, T 34 S, R 1 W, W.M.; 910 FEET NORTH AND 525 FEET WEST FROM THE CENTER 1/4 CORNER OF SECTION 15.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 1 (SE 1/4 NW 1/4) 0.93 ACRE SECTION 15
TOWNSHIP 34 SOUTH, RANGE 1 WEST, W.M.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 20, 1990 and together with Certificate 64425 supersedes Certificate 56208, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
