CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DAVID J. MOODY HCR 77, BOX 380 JOHN DAY, OREGON 97845

confirms the right to use the waters of THREE WELLS in the WILLOW CREEK BASIN for IRRIGATING 101.8 ACRES.

This right was perfected under Permit G-4506. The date of priority is FEBRUARY 10, 1969. This right is limited to 1.27 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The quantity of water appropriated at the new wells together with that appropriated from the old well shall not exceed the quantity of water available at the original well under the subject right.

The wells are located as follows:

WELL 1 - NE 1/4 SW 1/4, SECTION 15, T 15 S, R 42 E, W.M.; 1540 FEET NORTH AND 2930 FEET WEST FROM THE SE CORNER OF SECTION 15.

WELL 2 - SW 1/4 NW 1/4, SECTION 14, T 15 S, R 42 E, W.M.; 750 FEET NORTH AND 30 FEET EAST FROM THE W 1/4 CORNER OF SECTION 14.

WELL 3 - NE 1/4 SE 1/4 , SECTION 15, T 15 S, R 42 E, W.M.; 2390 FEET NORTH AND 4717 FEET EAST FROM THE SW CORNER OF SECTION 15.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

When in the judgement of the Watermaster it becomes necessary to install measuring devices:

the pump system shall include an access port for measuring the water level;

the pump system shall include an in-line flow meter or other suitable device for measuring the water to which the user is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change for AN ADDITIONAL TWO POINTS OF APPROPRIATION approved by an Order of the Water Resources Director entered DECEMBER 22, 1988 and supersedes Certificate 45528, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
